

## APPENDIX 2B – INSTRUCTION FOR REIMBURSEMENT ON PROJECT COST CALCULATION

The instruction sets following rules in accordance with the Executive protocol on the Agreement between the The Slovak Economic and Cultural Office in Taipei and the Taipei Representative Office in Bratislava in the field of Science and Technology signed on April 1, 2015 in Taipei and April 23, 2015 in Bratislava.

## TAIWANESE PARTY REFUNDS

This proposal only subsidizes the cost of living, transportation and insurance for the researchers who travel to the Slovak Republic. Research program expenditure such as staff costs, materials, computer fees, is not in the list of subsidies. The program is divided into one-year and two-year plans, subject to the implementation of the first year of the second year of the plan funding.

### For Taiwanese investigators:

Travel expenses for travels to/from Slovak Republic

The Republic of China (Taiwan) – Slovak Republic, the most direct range of economy class round-trip airfare and inland transportation costs, the maximum limit of NT \$ 55,000 per person.

- Health insurance during their stay in Slovak Republic
  Taiwanese research staff for the exchange program in Slovak Republic is to pay a comprehensive insurance, according to the actual travel date
- Stay expenses in the form of per diem allowances in Slovak Republic according to the national lawful rules and call conditions

Class A personnel: \$ 100 per day on day 1 and \$ 55 per day from day 15.

Class B personnel: \$ 130 per day on day 1 and \$ 70 per day from day 15.

- Funding subsidy: The Department is responsible for the cost of Taiwanese staff to the Slovak Republic
- Maximum subsidy: NT \$ 240,000 per case

# **SLOVAK PARTY REFUNDS**

### (maximum of 4 000 €/calendar year/project; and 8 000 € for project duration)

(Eligible costs provided by the Slovak Research and Development Agency in the terms of bilateral cooperation must be in compliance with the Slovak Act No. 283/2002 Coll. on Reimbursement of Travel Expenses)

### For Slovak investigators:

- travel expenses for travels to/from the Republic of China (Taiwan), taxi fares shall only be refunded in extraordinary and relevant cases)
- health insurance during their stay in the Republic of China (Taiwan)
- stay expenses and accommodation during the stay in the Republic of China (Taiwan)
  - per diem allowances (according the national lawful rules)
  - accommodation expenses (maximum of 100 €/night)
- during active participation in conferences, workshops, working meetings and other activities (research materials collection...) in Slovakia relevant to the project:
  - per diem allowances
  - accommodation expenses with maximum of 100 €/night

- travel expenses in Slovakiaconference fees
- other relevant expenses connected to transportation services (visa fees, ...) •
